The costs of any mediation will be shared equally between you and Vic Urban Plumbing Pty Ltd.

Notwithstanding any other provision in these Terms and Conditions, you and Vic Urban Plumbing Pty Ltd agree that you both retain the right to bring an action in small claims court and to bring an action for injunction relief or intellectual property infringement.

## 8. Severability

If at any time of the provisions set forth in these Terms and Conditions are found to be inconsistent or invalid under applicable laws, those provisions will be deemed void and will be removed from these Terms and Conditions. All other provisions will not be



affected by the removal and the rest of these Terms and Conditions will still be considered valid.
